FIRST OFFENSE

(for violations of 346.63(1)(am) or (b), penalty - 346.65(2)(a))

FORFEITURE: \$150 TO \$300 (plus surcharges and costs, except for a violation with minimum BAC. No alcohol assessment for (b) with minimum BAC level. DOT may require an assessment if conviction is for OAWI and not the BAC.

REVOCAATION: 6 - 9 MONTHS (no waiting; s.343.30(1q)(b)2.)
